- Be a qualified professional in the field of natural science with at least 5 (five) years of work experience, out of which preferably 3 (three) years shall be similar to the proposed assignment;
- Have working experience in environmental field, preferably under the projects funded by International Financial Institutions (experience of working in/for World Bank funded projects will be an advantage);
- Be familiar with the World Bank's Environmental and Social Framework;

- Have relevant practical skills in environmental management. Hands-on experience in environmental management (preferably supervision assignments) of infrastructure development projects will be an advantage;
- Have practical experience in carrying out environmental assessments of and management planning for infrastructure development projects, and/or implementing such plans (practical experience in road projects will be an advantage);
- Be knowledgeable of the Georgian environmental laws, regulations, and standards;
- Possess superior verbal and writing communication skills in English and Georgian languages

The period of the consultancy services shall be 1 year (with possibility of downstream extension, subject to satisfactory performance) and the remuneration will be time-based.
